









# Terms of Reference for the S4ILUP Advisory Board

## **Background**

Land use planning is high on the political agenda. Parties to multilateral environmental agreements recognize the importance of land use planning as a vehicle to reach biodiversity, food security and other environmental goals and to achieve land degradation neutrality (LDN). Integrated land use planning (ILUP) is a promising way towards a coherent approach across sectors and scales to implement different goals.

However, there are some challenges that prevent ILUP from being as effective as it could be. One possible entry point is harnessing the potential of the vast quantities of geospatial and economic data as well as information on sustainable land management to guide participatory ILUP processes.

Therefore, WOCAT, UNCCD, FAO, GEO-LDN and the ELD Initiative aim to address these challenges through an integrative process called *Scenarios for integrated land use planning* (S4ILUP), by facilitating knowledge exchange among key stakeholders from the land use planning, environment and data communities. Starting with a series of workshops, S4ILUP will build a lasting network and facilitate capacity development for evidence-based decision making in ILUP.

The series will consist of three workshops:

- WS 1: Land use planning expert side Identifying needs of users involved in ILUP processes
- WS 2: Technical provider side Analyzing academia and data provider approaches and tools to support land use planning
- WS 3: Joint opportunity scoping Identifying action points to support scenario development for ILUP

> An **advisory board** will be established to lay the foundation for a workshop design, which most adequately addresses current gaps and needs for actors in the land use planning field across the globe <

### **Profile**

- who are open for or ideally have experience with the concept of integrated land use planning (ILUP)
- with intersectoral work experience
- with knowledge of land degradation neutrality (LDN) or related environmental targets

# Composition of the advisory board:

The objective of the advisory board is to portray a holistic picture of the diverse perspectives on ILUP. Therefore, we aim for balanced representation of gender, regions and stakeholder communities including marginalized groups in the advisory board.

- the thematic focus of the workshops
- the composition of the workshop participants
- the design of the workshop series

## Expected workload:

- Time period: June-September 2022
- Tentative Dates for the advisory board meeting: 08 June 2022, 12-3pm CEST and 10 June 2022, 12-3pm CEST
- Max. 5hrs time-investment before the workshop series
- participation in the workshop series (approximately 3 half-day virtual workshops)
- Max. 6hrs of reflection and advice in between the workshops, possibly taking over roles within the advisory board as a group lead, speaker or coordinator
